We don't want your financial circumstances to stand between you and your future career as a solicitor. Whatever your personal circumstances or background, we have several funding options to help support you.

1. Payment Plans

We make it easier to enrol with our new simple payment plan, allowing you to split the cost of the SQE Prep course or bundle over up to 12 months, depending on how early you enrol.

This is how it works:

- You pay a £199 deposit if you enrol any month before the month of the course start date.
- OR a £500 down-payment if you enrol in the month of the course start date or later (up to the enrolment deadline).
- PLUS a £149 instalment administration fee, added to the total remaining sum payable.
- The balance is payable in regular equal instalments. A Visa, Mastercard or Amex credit or debit card is required for payment plans. Monthly payments are automatically charged to the card on file on the 1st working day of each subsequent month following the down-payment.
- You choose over how many months you want to pay it off, up to 12 months. The last instalment is due no later than the month of the exam, so the earlier you enrol, the more time you have to pay off the balance.
- Payment plans applies to all SQE1 Prep and SQE2 Prep courses and course bundles (eg bundling SQE1 Prep with SQE2 Prep, Foundations in Law, SQE1 Boost and/or SQE2 Mocks).
